

# COMPRESSED APPLICATION TIMELINE

#### MAIL IN VOTING

#### **SB 202**


- You can apply for your ballot
   78 days before an election.
   Revises §21-2-381, S.B. 202
   §25(a)(1)(A).
- Deadline to apply is **11 days** before the election. *Id.*

#### 2020

- You could apply for your ballot 180 days before an election.
- Deadline to apply was 3 days before the election.

# COMPRESSED BALLOT RETURN TIMELINE

#### MAIL IN VOTING

#### **SB 202**

 Counties cannot mail out ballots until 4 weeks before the election. Revises §21-2-384, S.B. 202 §27(a)(2).

#### 2020

 Counties could mail out ballots 7 weeks before the election.



# ID REQUIREMENTS TO APPLY

#### MAIL IN VOTING

#### **SB 202**

- To request a ballot, you'll need to include your driver's license number, state ID number or, if you don't have those, a copy of acceptable voter ID. Revises §21-2-381, S.B. 202 §25(a)(1)(C).
- DOB also required

#### 2020

 You were required to sign your application, and your signature was verified. Your DL and DOB were not required.



# ID REQUIREMENTS TO VOTE

#### MAIL IN VOTING

#### **SB 202**

 The outer envelope requires your printed name, signature, driver's license or state ID number (or last 4 digits of SSN) and date of birth. No SSN? Copy of ID. Revises §21-2-384, S.B. 202 §27(b); §28

#### 2020

 You were required to sign the outer envelope, and your signature was verified. Your DL was not required.



## NO ONLINE PORTAL?

#### MAIL IN VOTING

#### **SB 202**

 Likely no. The application requires "usual signature with pen and ink." Revises §21-2-381, S.B. 202 §25(a)(1)(C).

#### 2020

 The SOS created an absentee ballot application portal from which you could request your absentee ballot using your GA DL.



# WHO CAN PROVIDE APPLICATIONS

#### MAIL IN VOTING

#### **SB 202**

- No government entity can send voters an application to vote by mail.
- Third party groups still can, but cannot pre-fill the applications. Disclaimer required. Revises §21-2-381, S.B. 202 §25(a)(1)(C)(ii).

#### 2020

 Election officials at the state and county levels, as well as third party groups, mailed pre-filled applications to voters.



### DROP BOXES

#### MAIL IN VOTING

#### **SB 202**


- Drop boxes must be located in early vote sites and are accessible only during site hours. Revises §21-2-382, S.B. 202 §26.
- Drop boxes are capped at one per 100,000 active voters or one per EV site (whichever is fewer). Id.
- Each county must have one. Id.

#### 2020


- Drop boxes could be located outdoors and accessible 24/7.
- No cap on number of drop boxes.
- No requirement that counties offer a drop box.

# WHAT HAS NOT CHANGED?

#### MAIL IN VOTING

#### **SB 202**

- Absentee voting is still "No Excuse"
- Eligible voters can still opt in to the Roll Over List
- Timeline for counties to send ballots to UOCAVA voters (primaries and general)



# HOURS EXPANDED IN SMALL COUNTIES, CAPPED

# GEORGIA DEMOCRATS

## EARLY IN PERSON VOTING

#### **SB 202**

- EV sites must be open on weekdays from 9am - 5pm. Can extend to 7am - 7 pm. Revises §21-2-385, S.B. 202 §28.
- Second mandatory Saturday. Id.
- Sundays remain optional. Id.
- Primary and General Elections
   Only

#### 2020

- EV sites were open "during normal business hours" on weekdays, and authorized to expand beyond those hours.
- one mandatory Saturday
- Sundays were optional

# NO MOBILE VOTING UNITS

## EARLY IN PERSON VOTING

**SB 202** 

Prohibits mobile voting units.
 Revises §21-2-266, S.B. 202
 §20(b).

2020

 Did not prohibit mobile voting units

# EDAY PROVISIONAL BALLOTS

### ELECTION DAY VOTING

**SB 202** 

• Out of precinct provisional ballots will not count unless cast after 5 pm and voters signs a statement saying they cannot make it to correct precinct in time. Revises §21-2-418, S.B. 202 §34.

 Out of precinct provisional ballots count.

# EARLY PROCESSING OF ABSENTEE BALLOTS

# COUNTY ADMINISTRATION

#### **SB 202**

 Counties may begin processing absentee ballots as early as two weeks before election day. Revises §21-2-386, S.B. 202 §29(a)(2).

#### 2020

 Counties could begin processing absentee ballots as early as two weeks before election day after the passage of the emergency rule.



# BALLOT PROCESSING DEADLINE

#### COUNTY ADMINISTRATION

#### **SB 202**

- Counties must count all the ballots nonstop as soon as polls close.
   Revises §21-2-493, S.B. 202 §41.
- Counties must complete count by 5 pm the day after the election or be subject to SEB sanction. Revises §21-2-386, S.B. 202 §29(d).
- Certification is Monday after election. §21-2-493, S.B. 202 §41.

#### 2020

- Counties could take breaks counting ballots.
- Counties could count ballots until certification deadline.
- Certification is two Fridays after election



# OUTSIDE FUNDING

#### COUNTY ADMINISTRATION

#### **SB 202**

- No outside funding permitted directly to election office.
- Role of in kind donations?

#### 2020

 Counties were permitted to receive grants and in kind donations



# EQUIPMENT ALLOCATION

#### COUNTY ADMINISTRATION

#### **SB 202**

- One Ballot Marking Device per 250 active registered voters for statewide general elections.
   Revises §21-2-367, S.B. 202 §22.
- Precincts with over 2000 voters and wait times over an hour will have to make changes. Revises §21-2-263, S.B. 202 §18.

#### 2020

 One Ballot Marking Device per 250 active registered voters for any race.



# POLL WATCHING AND WORKING

#### COUNTY ADMINISTRATION

#### **SB 202**

- Poll watchers must receive training from party. Revises §21-2-408(e), S.B. 202 §32.
- Poll Workers may serve in adjoining counties. Revises §21-2-92, S.B. 202 §11.

#### 2020

- Poll watchers were not required to go through training by the state - but DPG always required training.
- Poll workers were limited to working in the county in which they were registered.



# SOS ROLE IS DIMINISHED

## STATE ELECTION BOARD

#### **SB 202**

 SOS will no longer chair SEB, and has a non-voting ex-officio role. Revises §21-2-30, S.B. 202 §5.

#### 2020

• SOS chaired SEB and was a voting member.



# STATE TAKEOVER OF COUNTY ELECTIONS

# STATE ELECTION BOARD

#### **SB 202**

 Allows the state legislature to take over county elections through control of the SEB and the Secretary of State's office.
 Revises §21-2-33.1, S.B. 202 §6. 2020

• Superintendents could not be removed by the legislature.



### CHALLENGES

#### **OTHER CHANGES**

#### **SB 202**

 Challenges must be heard in a timely matter and there is no limit on the number. Revises §21-2-299, S.B. 202 §15.

#### 2020

• The law was more ambiguous.



#### **OTHER CHANGES**

### RUNOFFS

#### **SB 202**

- Runoff will be four weeks long.
   Revises §21-2-501, S.B. 202 §42(a)(1).
- EV can be as short as 3-5 days. §21-2-385(d)(1)
- No more "jungle primary"
- Likely no new registrations

#### 2020

- Runoffs were nine weeks long.
- Early in person voting lasted three weeks.

#### **OTHER CHANGES**

**SB 202** 

UOCAVA voters can RCV. Revises
 §21-2-384, S.B. 202 §27(e)(6).

2020

• No RCV



# RESTRICTIONS ON NON PARTISAN LINE WARMING

#### OTHER CHANGES

**SB 202** 

Prohibits line warming
 activity within 150 ft of polling
 place or 25 ft of a voter in line.
 Revises §21-2-414, S.B. 202
 §33(a).

2020

 Permitted line warming activity within 150 ft of poling place or 25 ft of a voter in line



#### **OTHER CHANGES**

### AG HOTLINE

#### **SB 202**

 The AG has the authority to set up a hotline for people to file complaints about voter intimidation and illegal election activities.

#### 2020

 888-730-5816 is the DPG voter protection hotline. It's still the first number to call!



# LAUSUIS AND



### LAWSUITS

#### New Georgia Project v. Ra<mark>ffensperger</mark>

• SB 202 is based on false claim of voter fraud; lack justification for their burdensome and discriminatory effects.

#### Georgia NAACP v. Raffensperger

 Alleges SB202 is an effort to supress the participation of Black voters and other voters of color

#### AME Church v. Kemp

• Alleges SB202 intentionally discriminates against non-white voters

#### Asian Americans Advancing Justice - Atlanta v. Kemp

 Alleges SB202 will have a disparate impact on AAPI voters who mainly voted by mail in 2020

#### VoteAmerica v. Raffensperger

 Alleging provisions around third parties sending absentee ballot applications are unconstitutionally vague and overbroad.

#### Concerned Black Clergy v. Raffensperger

• Alleging SB202 targets voting practices disproportionately used by voters of color.

### FEDERAL LEGISLATION

#### HR 1 FOR THE PEOPLE ACT OF 2021

EXPANDS VOTING REGISTRATION AND ACCESS

#### HR 4 THE JOHN LEWIS VOTING RIGHTS ADVANCEMENT ACT

• AMENDS THE VOTING RIGHTS ACT

# STRATEGY 2021

### ENCOURAGE EARLY IN PERSON VOTING AS A FIRST CHOICE

SB202 makes VBM and Election Day Voting more difficult. For those who can vote in person, EIPV should be the preferred option.

### EXPAND EARLY IN PERSON VOTING

Data driven decisions about how many locations and where. County Commissions have to provide funding.

#### SUPPORT LIKELY VBM VOTERS

Messaging about VBM should be targeted to likely VBM voters. Key changes about VBM should be emphasized.

# KEEP REGISTERING VOTERS

This is something you can do now!

#### **GET IDS**

If you encounter a likely VBM voter, ask about ID situation.

Assist voters to get county voter IDs now

#### AMPLIYFY MESSAGING

Messaging about how, when and where to vote will go out. Amplify the message.

Clear, concise messaging is critical.

#### FOLLOW LOCAL BOE

Compensate for VBM restrictions by expanding EV options and convenience

BOE needs to be pro voter supported by budget
